## INTRODUCTION

With reference to Occupational Safety & Health (Safety & Health Officer) Regulations 1997 and Factories & Machinery (Building Operations and Works of Engineering Construction) (Safety), Regulations 1986; for any building operation and works of engineering construction projects with contract sum less than RM20 million:

- Main contractors are required to employ competent part-time Site Safety Supervisor at the place of work; and
- Sub-contractors with 20 or more workers must employ competent part-time Contractor's Safety Supervisor at the place of work.
- In general both the Site Safety Supervisor and Contractor's Safety Supervisor shall be responsible to:
  - ◇ Ensure that the provisions of statutory requirements with respect to safety and health matter are complied with;
  - ◇ Promote the safe conduct of work; and
  - ◇ Inspect and rectify any unsafe practices and conditions.

- 2 years' experience as Site Foremen/Supervisors/Safety Supervisors; or
- Diploma/Degree Holder in Civil or Mechanical or Electrical - Without work experience required; or
- Any qualifications approve by DOSH Malaysia
